Pursuant to the instruction of the Presidency dated 27 September 2023, this document is reclassified as Public.

The Presidency of the International Criminal Court (the 'Court')

In the case of *The Prosecutor v. Paul Gicheru*,

NOTING the 'Urgent Request for an Immediate Investigation into the Leak of the Defence Requests for the Disqualification of Judge Miatta Maria Samba and Temporary Stay of the Proceedings' dated 21 September 2021 (the 'Urgent Request'), in which the Defence for Mr Gicheru submits that urgent investigation is warranted of whether his confidential Request for the disqualification of Judge Samba (the 'Request for Disqualification') or his confidential Request for a temporary stay of proceedings (the 'Stay of Proceedings Request') were leaked to Kenyan media;

NOTING regulation 23*bis*(1) of the Regulations of the Court (the 'Regulations'), which states, *inter alia*, that any document shall be treated according to its classification throughout the proceedings;

NOTING regulation 29(1) of the Regulations, which determines that in case of non-compliance by a participant with, *inter alia*, the provisions of any regulation, the Chamber may issue any order that is deemed necessary in the interests of justice and **CONSIDERING** that the latter provision must necessarily apply *mutatis mutandis* to the Presidency;

CONSIDERING that the Presidency is responsible for safeguarding the security of the Request for Disqualification, which was filed before it, with any potential issues pertaining to documents filed before the Trial Chamber needing to be addressed to such Chamber;

ORDERS the Registry to provide the Independent Oversight Mechanism any information obtained in the course of its investigations that may fall within the scope of the jurisdiction of the latter;

ORDERS all parties to fully co-operate with the investigation; and

INSTRUCTS the Defence that any concerns regarding any potential leak of the Stay of Proceedings Request or the information contained therein may be addressed to Trial Chamber III.
