**TRIAL CHAMBER III** of the International Criminal Court, in the case of *The Prosecutor v. Paul Gicheru*, having regard to Article 64(6)(f), (7) and (10) of the Rome Statute, issues this 'Decision on Outstanding Procedural Matters'.

1. On 13 October 2022, the Registry filed a communication by the Republic of Kenya concerning the death of Mr Gicheru into the record of the case.<sup>1</sup> The Chamber hereby regulates outstanding matters requiring resolution before the termination of the proceedings.

2. The Chamber notes that, in conformity with the decision on the request for interim release, Mr Gicheru provided financial security to the Registrar in the value of 1.000.000 KSH.<sup>2</sup> The Chamber hereby instructs the Registry to return the financial security provided by Mr Gicheru to a competent member of the deceased's family. In this regard, the Defence is ordered to liaise with the Registry, as required.

3. Furthermore, the Chamber orders the parties and the Registry to review their respective filings in light of the termination of the proceedings. Should they consider that information which had to remain confidential can be made public at this point in time, they are ordered to either file lesser redacted versions of these filings into the record of the case or to request reclassification.<sup>3</sup> The parties are further directed to continue their cooperation with the Registry on any outstanding matter related to the verification of information which might be made available in the public record of the case.
