Judge **Péter Kovács**, designated on 28 March 2018 by Pre-Trial Chamber I ("Chamber") of the International Criminal Court ("Court") as Single Judge responsible for carrying out the functions of the Chamber in the case of *The Prosecutor v. Al Hassan Ag Abdoul Aziz Ag Mohamed Ag Mahmoud* ("*Al Hassan* case"), having regard to rule 15 of the Rules of Procedure and Evidence, decides as follows.

- 1. The Single Judge notes that some of his decisions and orders were rendered by email so as to expedite decisions on minor procedural matters or as required by the circumstances. In general, the decisions and orders were recorded by means of footnotes in the decisions that the Chamber entered into the record.
- 2. However, for the purpose of transmitting a complete record of proceedings to the Trial Chamber which will be constituted in the *Al Hassan* case, the Single Judge finds it appropriate to enter into the record all decisions and orders rendered by email thus far, as listed in Annex A and contained in Annex B to this decision. This will enable the relevant Trial Chamber to apprise itself of all the decisions and orders rendered by the Chamber in that manner.
