The three judges of the Appeals Chamber of the International Criminal Court,

In the review by the Court concerning reduction of sentence of Mr Ahmad Al Faqi Al Mahdi (hereinafter: "Mr Al Mahdi") pursuant to article 110 (3) of the Statute,

Noting the procedure for the review concerning reduction of sentence set out in rule 224 (1) of the Rules of Procedure and Evidence (hereinafter: "the Rules"),

Noting the "Decision re-scheduling the hearing before the three judges of the Appeals Chamber" of 29 July 2021 (ICC-01/12-01/15-403), in which it rescheduled the hearing to 12 and 13 October 2021,

Noting the Registrar's filing of the "Responses of the Authorities of the Republic of Mali and of the United Kingdom of Great Britain and Northern Ireland to the Orders for the review concerning reduction of sentence of Mr Ahmad Al Faqi Al Mahdi, ICC-01/12-01/15-392 and ICC-01/12-01/15-398" of 27 July 2021 (ICC-01/12-01/15-402), in which the Registrar conveyed that the Embassy of the United Kingdom of Great Britain and Northern Ireland indicated that, without prejudice to the possible participation of its Home Office, it did not intend to participate in the hearing,<sup>1</sup>

## ORDER

- The duration of the hearing for the purpose of the review concerning reduction of sentence of Mr Al Mahdi shall be limited to Tuesday, 12 October 2021. As a result, the additional date scheduled, namely Wednesday, 13 October 2021, is hereby vacated.

During the hearing, the parties and participants may address any relevant issues pertaining to the review concerning reduction of sentence without exceeding those raised in their or the other participants' written submissions. Noting the level of confidentiality applied to the proceedings, thus far, the parties and participants are requested to provide an indication before their respective interventions as to whether they may be conducted partly in open session.
- 4. Moreover, the parties and participants are requested to address the below issues in their oral submissions, as follows:
  - a) The Prosecutor, Defence and Legal Representative of Victims are requested to address (i) the meaning of "a clear and significant change of circumstances sufficient to justify the reduction of sentence" as provided in article 110(4)(c) of the Statute and (ii) the legal basis, if any, for the imposition of conditions in connection with the early release of Mr Al Mahdi .
  - b) The Defence is requested to address in particular the criteria set out in articles 110(4)(a) to (c) of the Statute and rules 223(a), (c) and (e) of the Rules.
  - c) The Legal Representative of Victims is requested to further elaborate on his submissions at paragraph 19 concerning the impact of early release of Mr Al Mahdi, if granted, on the reparations process.

- d) The Republic of Mali is requested to specifically address the impact of early release, if granted, on the people of Mali as a whole and how it views Mr Al Mahdi's claims concerning his expression of remorse for the crimes he committed and his ability to reintegrate into society.
- 5. The Defence and the Prosecutor are directed to file public redacted versions of their respective submissions by Wednesday, 6 October 2021 as listed below:
  - a) ICC-01/12-01/15-419-Conf-Exp;
  - b) ICC-01/12-01/15-420-Conf-Exp-Corr.
- 6. The Registry, the Legal Representative of Victims, the Republic of Mali and the United Kingdom of Great Britain and Northern Ireland are directed to file public redacted versions of their respective submissions by Friday, 8 October 2021 as listed below:
