I. **Procedural background**

1. On 9 February 2023, Trial Chamber I (the 'Chamber') issued a decision extending the deadline for submitting victims' applications in the present case until the end of the case of the Common Legal Representative of Victims (the 'CLRV').¹

2. On 5 May 2023, the Registry filed a second request for an extension of time limit to submit victims' applications in the present case, seeking that the Chamber further extends the time limit for the submission of victim applications until the end of the CLRV's case (and the transmission of victims' applications on a rolling basis as soon as possible thereafter) (the 'Request').²

3. On 10 May 2023, the CLRV filed her observations to the Request (the 'Observations') in support of the Request.³

4. On 12 May 2023, the Defence filed a response stating it does not oppose the Request (the 'Defence Response').⁴

5. The Prosecution did not file a response.

II. **Applicable law**

The Chamber incorporates by reference the general framework applicable to the 6. extension of time limits pursuant to Regulation 35(2) of the Regulations of the Court (the 'Regulations').⁵

III. Submissions and analysis

7. The Chamber notes that in the Request, the Registry reports that the outbreak of the conflict in Sudan has hindered the victims' application process. The Registry informs that as a result, victims may be displaced, internet and other communication services have been interrupted, and given the security situation intermediaries are facing difficulties to carry out

activities in the field.⁶ As acknowledged by the CLRV,⁷ and the Defence,⁸ the Registry could not have anticipated the ongoing conflict in Sudan.

8. The Chamber further notes that in the Request the Registry reports that the number of victims' applications has significantly scaled up and that their processing has been delayed by the Court's current capacity of Arabic translators.⁹ The Chamber accepts the CLRV's submission that victims should not be disadvantaged by the Court's limitations on translation resources. The Chamber observes the CLRV's suggestion that the deadline should apply to applications in their original language and not the translation thereof. ¹⁰

9. Moreover, the Chamber observes that the Registry,¹¹ the CLRV¹² and the Defence¹³ all agree that granting the Request would not be incompatible with Mr Abd-Al-Rahman's right to be tried without undue delay. Furthermore, as observed by the CLRV, victims admitted after the conclusion of the CLRV case will be able to participate in 'several important procedural events'.¹⁴

10. Accordingly, the Chamber finds that good cause is shown for the extension of the time limit.

11. The Chamber observes the Registry's submission that the victims' applications assessed as complete could be transmitted in a few months, following their translation. The Chamber further observes the Registry's proposal to provide an update to the Chamber as soon as the deadline for victims to submit their applications has expired.¹⁵

12. For the above reasons, the Chamber grants the Request and sets the following deadlines:

a. Victims may submit to the Registry applications to participate in the proceedings no later than 7 June 2023;¹⁶

- Registry is to report to the Chamber, by 14 June 2023, on the status of translation of victims' applications submitted to the Registry;
- c. The Registry is to transmit to the Chamber the English translation of the submitted victims' applications, pursuant to the ABC Approach, on a rolling basis.
