#### I. Introduction

1. The Registry submits the present report ("Registry Report") and its two annexes consisting of a confidential version of items recognized as evidence formally submitted and its public redacted version, pursuant to the "Directions on the conduct of proceedings" ("Directions"), issued by Trial Chamber I ("Chamber") on 4 October 2021.<sup>1</sup>

### **II. Procedural History**

- 2. On 4 October 2021, the Chamber issued its Directions, in which it directed the Registry to: "[...] reflect all formally submitted items in the eCourt metadata [...]", and to "[...] submit reports for each witness who testifies, indicating which items have been formally submitted by the parties and participants in relation to that witness. The email exchanges [...] are to be annexed to this filing, applying redactions as appropriate".<sup>2</sup>
- 3. On 24 January 2023, the Office of the Prosecutor ("Prosecution") called its fifty-third witness, witness P-1049. After the conclusion of the examination of witness P-1049, the parties formally submitted items used during the hearings of the said witness, as instructed in the Directions.
- 4. On 3 February 2023, the Chamber, via email, issued the decision on items of evidence recognised as formally submitted for witness P-1049.<sup>3</sup> Pursuant to the Directions, the Registry was instructed to apply redactions as appropriate to the emails in Annex 1 to the present filing.
