

#### I. Introduction

 In compliance with Pre-Trial Chamber II ("Chamber")'s instruction of 28 September 2023,<sup>1</sup> the Registry hereby submits its observations for the purpose of the Chamber's review of its ruling regarding the interim release, if any, of Mr Maxime Jeoffroy Ali Mokom Gawaka ("Mr Mokom").

# II. Procedural history

- 2. On 8 March 2023, the Chamber issued the "Decision on interim release",<sup>2</sup> whereby it rejected Mr Mokom's application for interim release,<sup>3</sup> noting that its decision "is without prejudice to any future determination that may be made under article 60(3) of the Statute, in particular if a State identified in the Application that has not responded hitherto nonetheless indicates its willingness to receive Mr Mokom for the purpose of interim release".<sup>4</sup>
- 3. On 27 March 2023, the Defence in its request for interim measures ("Request") provided a list of [REDACTED] priority States Parties, namely, [REDACTED] as being potential realistic and credible candidates to cooperate with the Court, and informed the Chamber that it took steps to contact these [REDACTED] States.<sup>5</sup> In addition, the Defence requested the Chamber *inter alia* to order the Registry to contact all previously contacted States to advise on the new developments in these proceedings, including Chamber's finings in the Decision of 8 March 2023, detailed in paragraph 24 of the Defence's Request.<sup>6</sup>

- 4. On 19 April 2023, the Chamber in its Decision on the "Defence Request for Interim Measures" ordered the Registry to, "in consultation with the Defence, contact any of the States identified in the Request (excluding [REDACTED]), and to report to the Chamber in the event that any such State accepts Mr Mokom for the purposes of interim release".<sup>7</sup>
- 5. On 15 June 2023, pursuant to the Chamber's instructions of 7 June 2023 sent by email,<sup>8</sup> the Registry provided its observations relating to its consultations with the [REDACTED] priority States.<sup>9</sup> During these consultations [REDACTED] and [REDACTED] re-confirmed that they would not be able to accept Mr Mokom on their territory.<sup>10</sup>

# III. Classification

6. Pursuant to regulation 23 *bis*(1) and (2) of the Regulations of the Court ("RoC"), the present submission is classified as confidential as it refers to sensitive information contained in confidential documents and information on confidential exchanges with the States parties. A public redacted version will be filed in due course.

### IV. Applicable law

 The following provisions are of particular relevance to the present submission: article 60(2) and (3) of the Rome Statute, rules 118 and 119 of the Rules of Procedure and Evidence and regulation 51 of the RoC.

#### V. Submissions

- 8. To date, the Registry received a confirmation from the [REDACTED] authorities that that the position of [REDACTED] as provided in a note verbale of 9 February 2023,<sup>11</sup> has not changed.
- 9. In addition, the authorities of [REDACTED] replied that they are not in the position to accept Mr Mokom on their territory.
- 10. No further responses have so far been received by the Registry from [REDACTED]. The Registry will continue following up with these States.
