The Appeals Chamber of the International Criminal Court,

In the appeal of the Bolivarian Republic of Venezuela against Pre-Trial Chamber I's "Decision authorising the resumption of the investigation pursuant to article 18(2) of the Statute" of 27 June 2023 (ICC-02/18-45),

Pursuant to regulation 23bis(3) of the Regulations of the Court,

Issues the following

ORDER

The Registrar is directed to reclassify as public filing ICC-02/18-49-Conf-Exp-AnxII.

REASONS

1. Regulation 23bis(3) of the Regulations of the Court provides that a Chamber may reclassify a document when the basis for the classification no longer exists.
2. The Appeals Chamber notes that in "The Bolivarian Republic of Venezuela's Application for Extension of Time to File the Appeal Brief", the Bolivarian Republic of Venezuela submits that "[a]s soon as a public redacted version [of its notice of appeal] is filed, the present filing can be reclassified as public".¹ As a public redacted version of said notice of appeal has been filed,² the Appeals Chamber finds that no reason exists for "The Bolivarian Republic of Venezuela's Application for Extension of Time to File the Appeal Brief" to remain confidential, and directs that this document be reclassified as public.
