PRE-TRIAL CHAMBER II (the ‘Chamber’) of the International Criminal Court (the ‘Court’), following its recomposition, issues this decision on the election of the Presiding Judge.


1. On 12 March 2024, the Presidency of the Court recomposed the Chambers and assigned the following situations and cases therein to the Chamber: Central African Republic I; Central African Republic II; Darfur, Republic of the Sudan; Republic of Kenya; Republic of Côte d’Ivoire; Islamic Republic of Afghanistan; Republic of Burundi; and Ukraine.¹
2. The Chamber notes regulation 13(2) of the Regulations of the Court, pursuant to which the Judges of each Pre-Trial Chamber ‘shall elect from amongst their members a Presiding Judge who shall carry out the functions conferred upon him or her by the Statute, Rules or otherwise’.
3. On 13 March 2024, the Judges of the Chamber elected Judge Rosario Salvatore Aitala to act as the Presiding Judge of the Chamber with immediate effect.

FOR THESE REASONS, THE CHAMBER HEREBY

- a) **ANNOUNCES** the election of Judge Rosario Salvatore Aitala as the Presiding Judge of Pre-Trial Chamber II; and
- b) **ORDERS** the Registrar to file and notify the present decision to the relevant parties and participants in the following situations: Central African Republic I; Central African Republic II; Darfur, Republic of the Sudan; Republic of Kenya; Republic of Côte d'Ivoire; Islamic Republic of Afghanistan; Republic of Burundi; and Ukraine.
