## I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

## III. SUBMISSIONS

3. The Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 134” containing eight items and “Trial Rule 77 package 102” containing five items on 5 April 2024.
