NOTING the "Request to the Lybian Arab Jamahiriya for the arrest and surrender of Muammar Mohammed Abu Minyar Gaddafi, Saif Al-Islam Gaddafi and Abdullah Al-Senussi" dated 4 July 2011;³

NOTING Article 87 (1) (a) of the Rome Statute, Rule 176(2) of the Rules of Procedure and Evidence and Regulation 24 *bis* of the Regulations of the Court;

CONSIDERING that various media sources reported the death of Muammar Mohammed Abu Minyar Gaddafi on 20 October 2011;

INFORMS the Chamber as follows:

 On 27 October 2011 the Registry transmitted a request for assistance to the Libyan authorities in order to request them to transmit the death certificate of Muammar Mohammed Abu Minyar Gaddafi;

- On 4 November 2011, the Embassy of Libya to the Kingdom of the Netherlands transmitted a copy of the death certificate of Muammar Mohammed Abu Minyar Gaddafi issued by the Civil Registration Office in Misrata;
- In the absence of a diplomatic pouch the death certificate was received by fax by the Embassy of Libya. The Embassy indicated that it would also request a hard copy the document;
- 4. The translation of the document into English was finalized by the Registry on 8 November 2011.
