**Others** Ciré Clédor Ly Judge Silvia Fernández de Gurmendi, Single Judge for Pre-Trial Chamber I (the "Chamber") of the International Criminal Court (the "Court"), responsible for carrying out the functions of the Chamber in relation to the situation in the Republic of Côte d'Ivoire and the cases emanating therefrom,¹ issues the following decision on the "Requête au fins d'être autorise à se retirer d'une affaire sur le fondement : 1. Des articles 21 ; 67-1(d) du Statut de Rome 2. De la Norme 78-1 du Règlement de la Cour 3. Des articles 18-3 ; 27 du Code de Conduit Professionnelle des Conseils 4. De l'article 14-3(d) du Pacte International Relatif au Droit Civils et Politiques" (the "Request"), filed by Ciré Clédor Ly on 17 February 2014.²

- 1. On 1 November 2013, the Registrar filed in the record of the case a power of attorney, dated 30 July 2011, signed by Simone Gbagbo in favour of Clédor Ciré Ly to represent her in the proceedings before the Court.<sup>3</sup>
- 2. On 25 November 2013, Simone Gbagbo personally executed the "Annulation mandate CPI de Maître Ciré Clédor Ly", which was filed in the record of the case in February 2014.<sup>4</sup> On the same day, Simone Gbagbo issued a power of attorney appointing Sylvia Geraghty as her lead counsel in the proceedings before the Court.
- 3. On 22 January 2014, Simone Gbagbo issued the "Confirmation de Mandat Special", whereby she confirmed her power of attorney in favour of Sylvia Geraghty, the appointment of two legal assistants, and the discharge of Ciré Clédor Ly from her defence team.<sup>5</sup>
- 4. As a result of these developments, on 17 February 2014, Ciré Clédor Ly, who in the meantime had been registered as co-counsel for Simone Gbagbo,

filed the Request, whereby he requests the Chamber to authorise him to withdraw from the present case.

5. The Single Judge notes article 67(1)(d) of the Rome Statute, regulation 78(1) of the Regulations of the Court, and article 18(3) of the Code of

Professional Conduct for counsel.

6. The Single Judge notes that, as recalled above, it is Simone Gbagbo's expressed wish to discharge Ciré Clédor Ly and to differently compose her own defence. Indeed, Simone Gbagbo executed a power of attorney in favour of Sylvia Geraghty to act as her lead counsel and designated two legal assistants as part of her defence team, confirming that as of 22 January 2014 "Maître Ciré Clédor Ly ne fait plus partie de mon équipe de défense devant la Cour Penale Internationale". 6 In these circumstances, the Single Judge sees no

obstacle to Ciré Clédor Ly withdrawing from the present case in accordance

with Simone Gbagbo's own wish.

FOR THESE REASONS, THE SINGLE JUDGE

**AUTHORIZES** Ciré Clédor Ly to withdraw from the case of *The Prosecutor* v. *Simone Gbagbo*.
