**CONSIDERING** that during the closed session hearing held on 23 November 2015 the Single Judge ordered the Registrar to file a report on the article 56 proceedings for each witness, to annex to every report the audio and video recording of each testimony, and to include the reference(s) to the relevant transcript(s);<sup>3</sup>

**RESPECTFULLY SUBMITS** the following report:

1. Witness UGA-OTP-P-0101 testified in closed session on 9 and 10 November 2015 and in the presence of the Defence and the Prosecution (the "testimony").
