**TRIAL CHAMBER II** ("the Chamber") of the International Criminal Court, acting pursuant to regulation 35(2) of the Regulations of the Court ("the Regulations"), issues the following decision.

## I. Procedural background

- 1. On 16 September 2016, the Office of Public Counsel for Victims ("the OPCV") filed a request informing the Chamber of developments since the Chamber's order of 15 July 2016<sup>1</sup> and seeking guidance on the modalities the Chamber wished to see put in place "[TRANSLATION] to further the reparations proceedings in the instant case"<sup>2</sup> ("the OPCV's Request").
- 2. On 20 September 2016, the Chamber issued an order fixing a timetable for the filing of observations on the Request<sup>3</sup> ("the Order of 20 September 2016").
- 3. On 21 September 2016, the Trust Fund for Victims ("the TFV") filed a request for an extension of the time limit to submit its observations on the Request<sup>4</sup> ("the Extension Request").
- 4. On 22 September 2016, the OPCV filed a response to the Extension Request, asking the Chamber to reject it.<sup>5</sup>

## II. Analysis

5. The Chamber recalls that, according to the first sentence of regulation 35(2) of the Regulations, a Chamber may extend a time limit if good cause is shown.

6. In support of its request, the TFV asserts that the drafts prepared by its Secretariat must be submitted to the TFV Board of Directors for review and approval before they can be filed before the Court.<sup>6</sup> Moreover, the TFV submits that this internal review process takes a minimum of five working days.<sup>7</sup> Consequently, the time limit of 26 September set by the Chamber in its Order of 20 September 2016 does not allow enough time to complete the internal review process.<sup>8</sup> The TFV accordingly requests that the time limit be extended to 3 October 2016.<sup>9</sup>

7. In its response, the OPCV submits that the TFV has known about the Request since 16 September 2016 and that the Request merely reiterates the developments already described in its observations of 1 July 2016<sup>10</sup> and already discussed with the TFV and the Registry.<sup>11</sup> The OPCV also points out that the Chair of the Board of Directors is currently in The Hague and that this should facilitate the TFV's internal process.<sup>12</sup> Lastly, the OPCV submits that the Request merits immediate resolution by the Chamber.<sup>13</sup> In the OPCV's view, therefore, the cause given by the TFV does not warrant an extension under regulation 35(2) of the Regulations.<sup>14</sup>

8. Although the points raised in the Request are not new, the Chamber considers that a one-week extension of the time limit, as sought by the TFV, is appropriate. Accordingly, the Chamber grants an extension until 3 October 2016. The Chamber also sees fit to grant the same extension to the Registry, so that the Chamber may receive the Registry's observations on the same day. Ultimately, the Chamber

extends until 6 October 2016 the time limit set in the Order of 20 September 2016 for the legal representatives of victim groups V01 and V02 ("the Legal Representatives of V01 and V02 Victims") and the Defence team representing Thomas Lubanga Dyilo ("the Defence") to submit their observations on the Request and on the observations of the TFV and the Registry.

FOR THESE REASONS, the Chamber

**GRANTS** the Extension Request;

GRANTS the TFV and the Registry an extension of time limit until

3 October 2016 to submit their observations on the Request; and

EXTENDS until 6 October 2016 the time limit for the Legal Representatives of

V01 and V02 Victims, and the Defence, to submit their observations on the

Request and on the observations submitted by the TFV and the Registry by

3 October 2016.
