## A. Procedural background

- 1. On 24 March 2017, the Chamber issued the Order for Reparations pursuant to article 75 of the Statute ("Order for Reparations"),1 wherein, for the purpose of reparations, it accorded the locus standi of victim to two hundred and ninety-seven (297) applicants for reparations – of whom two hundred and eighty-three (283) are represented by the Legal Representative - and awarded them both individual and dedicated collective reparations<sup>2</sup> for the total harm suffered, which it assessed at USD 3,752,620. The Chamber set the reparation award for which Mr Katanga is liable at USD 1,000,000.
- 2. In the operative part of the Order for Reparations, the Chamber directed the Trust Fund for Victims ("Trust Fund") to prepare a draft plan for the implementation of the Order for Reparations ("Draft Plan") to be submitted to the Chamber by 27 June 2017. The Chamber also directed observations on the Draft Plan from the Legal Representative and the Defence by 28 July 2017. On 22 June 2017, in response to a request by the Trust Fund,<sup>3</sup> the Chamber extended the time limit for submitting the Draft Plan to 11 July 2017.4 This time limit was further extended to 25 July 2017 by another decision of the Chamber,<sup>5</sup> again in response to a request by the Trust Fund.6
- 3. On 25 July 2017, the Trust Fund filed its draft implementation plan.<sup>7</sup>
- 4. In the Chamber's decision granting the Trust Fund a second extension of time, it set 4 September 2017 as the time limit for the Legal Representative, the Defence and

the Office of Public Counsel for Victims ("OPCV") to submit their observations. In response to a request made by the Legal Representative,<sup>8</sup> the time limit for submitting the observations was extended to 11 September 2017.<sup>9</sup>

5. The Chamber's Order for Reparations did not set a page limit for the draft implementation plan or for the parties' observations on the Draft Plan.

## B. Purpose of the request

6. Pursuant to regulation 37 of the Regulations of the Court, the Legal Representative requests the Chamber to extend the number of pages authorized for the submission of observations on the Trust Fund's draft implementation plan to a maximum of 40 pages.

#### C. Submissions

- 7. Thus far, the Legal Representative has considered that it would be possible to present his observations within the 20-page limit prescribed under regulation 37 of the Regulations of the Court. He has done his utmost to stay within that limit by systematically paring down all the parts, by summarizing and by discarding certain points.
- 8. Despite all efforts to comply with the page limit in accordance with regulation 37 of the Regulations of the Court, the Legal Representative considers that he has reached the limit of the cuts he can reasonably make if he wishes to file observations that are truly relevant to the Chamber, the Defence, the OPCV and the Trust Fund. The Legal Representative considers that any further condensation of his written observations will render them too brief on certain points, thus depriving the Chamber, the parties and the participants of any clarification concerning important issues and the reasoning of the Legal Representative.
- 9. Further, the Legal Representative wishes to point out that his observations are in response to the draft implementation plan which is 52 pages long<sup>10</sup> with five

annexes. Three of the five annexes are available to the Legal Representative: Annex 1 (5 pages), Annex 2 (3 pages) and Annex 5 (49 pages).

10. The Legal Representative was unable to file this request earlier for the simple reason that to date, he has been seeking ways of reducing as much as possible the number of pages of his submissions.

FOR THESE REASONS, the Legal Representative RESPECTFULLY REQUESTS THE CHAMBER to admit this request and to grant it.
