## I. Transmission

1. The Registry submits this report and its related annexes pursuant to Trial Chamber VII's "Order on Sentencing Submissions following Appeals Chamber Judgments" ("Order"), by which it ordered the Registry to file an updated report on the solvency of each of the convicted persons in the present case ("Report").<sup>1</sup>
2. The Registry notes the request by the defence for Mr Jean-Pierre Bemba Gombo ("Mr Bemba") before Trial Chamber III to be given access to information in the case ICC-01/05-01/08 ("Request").<sup>2</sup> The Registry is ordered to file its observations on the Request by 19 April 2018. Accordingly, pending adjudication of the Request, the Registry limits his submissions to updated information known by Mr Bemba and information in the case ICC-01/05-01/08 that the Registry is authorised to share in the present case.<sup>3</sup>
3. Accordingly, the Registry submits the following annexes:
  - a. Annex I on Mr Bemba Gombo's solvency;
  - b. Annex II on Mr Kilolo Musamba's solvency; and
  - c. Annex III on Mr Mangenda Kabongo's solvency.


