I. INTRODUCTION

1. Pursuant to Rules 132(2) and 132 *bis*(4) of the Rules of Procedure and Evidence ('RPE') and Regulation 54 of the Regulations of the Court, the Defence for Dominic Ongwen ('Defence') hereby requests Trial Chamber IX ('Chamber') to hold a status conference during the latter part of June 2018.

II. CONFIDENTIALITY

2. Pursuant to Regulation 23 *bis*(2) of the Regulations of the Court, the Defence submits this request confidential *ex parte*, Chamber and Defence only. A public redacted version is filed contemporaneously.

III. PROCEDURAL HISTORY

- 3. On 21 January 2015, Mr Ongwen was transferred to the seat of the Court.
- 4. On 26 January 2015, Mr Ongwen made his initial appearance before the Court.
- 5. From 21 January through 27 January 2016, Pre-Trial Chamber II held the Confirmation of Charges Hearing in the case of *The Prosecutor vs Dominic Ongwen*.
- 6. On 23 March 2016, Pre-Trial Chamber II issued its decision on the Confirmation of Charges Hearing, sending the case to trial.
- 7. On 23 May 2016, the Chamber held a status conference pursuant to Rule 132(1) and Regulation 54 of the Regulations of the Court.¹
- 8. On 6 December 2016, the trial in *The Prosecutor vs Dominic Ongwen* opened.²
- 9. On 16 January 2017, the Prosecution called its first witness.³

11. On 13 April 2018, the Prosecution officially closed it case-in-chief in the case of

The Prosecutor vs Dominic Ongwen.⁵

12. On 4 May 2018, the Chamber informed the Defence that it would not have to

start its presentation of evidence until after the summer recess.6

IV. SUBMISSIONS

13. As the Chamber did before the beginning of the Prosecution's case-in-chief,

the Defence requests a status conference during the latter part of June 2018.

The Defence respectfully requests that a representative from VWU is present

during the status conference.

14. The Defence notes that the amount of witnesses which it intends to call,

approximately 82 witnesses, around 66 of which shall be live witnesses,

necessitates a status conference.

16. The Defence is also in the process of finalising contracts of new expert

witnesses, which the Defence could not start until the beginning of April 2018

when it was informed by CSS that the Defence received an additional €50,000

for its investigations and expert witnesses. The Defence would like to discuss

the modalities of the witnesses' appearances.

17. Furthermore, the Defence also wishes to discuss the modalities of a medical

examination by Chamber appointed experts pursuant to Rule 135 of the RPE.

During the time between now and the requested status conference, the

Defence intends to conduct *inter partes* discussions concerning recommendations to the Chamber of expert psychiatrists and psychologists for the examination. The requested examination would be for an expert examination and report concerning the Defence's Article 31(1)(a) affirmative defence.

V. RELIEF

18. The Defence respectfully requests the Chamber to schedule a status conference during the latter part of June 2018 for the purpose of discussing the abovementioned issues and any other pertinent issues.
