**PRE-TRIAL CHAMBER II** of the International Criminal Court hereby issues this decision on 'Mr. Bemba's Request for Leave to Reply to Prosecution's response and Registry's Observations to Mr. Bemba's claim for compensation and damages (ICC-01/05-01/08-3680-Red and ICC-01/05-01/08-3681-Red3)' (the 'Request'). <sup>1</sup>

- 1. On 14 March 2019, Pre-Trial Chamber II ordered the Registry to submit its observations on Mr. Bemba's claim for compensation and damages (the 'Claim')<sup>2</sup> and allowed the Prosecutor to file its response to the Claim with both a time and page limit extension.<sup>3</sup>
- 2. On 6 May 2019, the Prosecutor<sup>4</sup> and the Registry<sup>5</sup> respectively filed their response to and observations on the Claim. On 8 May 2019, Mr. Bemba requested this Chamber to be granted leave to file a reply to the Prosecutor and the Registry's submissions, no later than 10 June 2019 and with a variation of the page limit to 50 pages.<sup>6</sup> On 10 May 2019, the Prosecutor opposed the Request.<sup>7</sup>
- 3. The Chamber, being aware of the novelty and complexity of several of the issues raised in these compensation proceedings, and noting that both the Prosecutor and the Registry raised new facts and information in their submissions, finds that there exist sufficient

reasons to grant the Request. The Chamber underlines that the reply shall be limited to the new facts and information identified in the Request.

- 4. By the same token, the Chamber is not satisfied that these reasons are tantamount to exceptional circumstances that may justify an extension of the page limit up to 50 pages. Also, a six-week lapse of time to provide a reply would be excessive. Therefore, Mr. Bemba shall file a response not exceeding 20 pages and no later than 4 June 2019.
- 5. Additionally, according to rule 174(1) of the Rules of Procedure and Evidence, the Prosecutor shall have an opportunity to respond to Mr. Bemba's reply. The Chamber also finds it adequate for the Registry to be allowed to respond to the forthcoming Mr. Bemba's filing. Hence, both the Prosecutor and the Registry may file their responses not exceeding the 20-page limit and no later than 26 June 2019, if they so wish.
- 6. The Chamber emphasises that, in the interests of reasonable finality, no further submissions will be allowed in these proceedings.

## FOR THESE REASONS, THE CHAMBER

**PARTLY GRANTS** the Request, allowing Mr. Bemba to file a reply not exceeding 20 pages and no later than 4 June 2019;

**DECIDES** that the Prosecutor and the Registry may file their responses to the abovementioned reply not exceeding 20 pages and no later than 26 June 2019, if they so wish.
