### Prosecution request for reclassification

1. On 14 April 2020, the Prosecution filed the "Prosecution's provision of information in relation to further written submissions".<sup>1</sup> The same day, the Prosecution filed a corrigendum of this filing ("Corrigendum"),<sup>2</sup> together with an annex explaining the correction made ("Annex").<sup>3</sup> The Prosecution filed the Corrigendum and Annex confidentially as they referred to the contents of a confidential filing by the Defence for Mr Gbagbo ("Defence filing").<sup>4</sup>
2. Since the Defence filing has been reclassified to public pursuant to the Chamber's order of 11 May 2020,<sup>5</sup> there is no longer a basis for maintaining the confidentiality of the Corrigendum and the Annex.
3. Accordingly, and pursuant to the Chamber's order dated 17 June 2020,<sup>6</sup> the Prosecution requests that the Corrigendum and the Annex be reclassified to public.
