I. Introduction

1. The Registry hereby informs the Pre-Trial Chamber II that Mr Iain Edwards, a lawyer on the List Counsel of the International Criminal Court ("Court") has been appointed as Associate Counsel for Mr Ali Muhammad Al Abd-Al-Rahman ("Mr Abd-Al-Rahman") to represent him in proceedings before the Court. The appointment has been formalized by letter dated 12 July 2021.

II. Classification

III. Applicable Law

3. 4. On 12 July 2021 the Registry formalised the appointment of Mr Edwards as Associate Counsel.¹
