### Introduction

#### Remarks

- 2. On 24 November 2020, the Office of the Prosecutor sent to the Defence the link to *Rule 77 Trial Bundle No. 95* containing twenty-one pieces of evidence.
- 3. This material is disclosed in accordance with the e-Court Protocol and is directly accessible in *Records Manager*.
- 4. The material is listed and described in the table in Annex A attached hereto.
- 5. The bundle is composed of the log of the preparation of Witness P-0565, newspaper articles, photographs and videos, and the transcript of a video.
- 6. This material does not require any redaction in the metadata.
- 7. The content of one the pieces of evidence requires redaction. Redaction codes A.3.2 and B.2 have been applied. The Office of the Prosecutor has thus in essence complied with the Single Judges' decisions of 16 May 2018<sup>1</sup> and 30 December 2019.<sup>2</sup> The codes are listed in the table in Annex A (in the right hand column entitled: ICC-01/12-01/18 Redactions applied to the content of the document).
