1. In accordance with Regulation 78(1) of the Regulations of the Court, I hereby respectfully request leave to withdraw as Associate Counsel for Mr Al Hassan in the case of *Prosecutor v. Al Hassan Ag Abdoul Aziz Ag Mohamed Ag Mahmoud* (ICC-01/12-01/18) with immediate effect.

2. I submit this request with the consent of both Mr. Al Hassan and Lead Counsel.

3. According to Article 16 of the Code of Professional Conduct for Counsel, Counsel shall seek leave of the Chamber to withdraw from representation of the client if a conflict of interests arises between the client and any other person.

4. A conflict of interests has indeed arisen between Mr. Al Hassan and a person who was represented by a colleague of mine at my law firm in Amsterdam, Prakken d'Oliveira *Human Rights Lawyers*. I have informed the Prosecutor about the nature of the conflict and of the fact that under the Dutch Code of Conduct, conflicting interests can also arise between clients represented by different advocates within the same law firm. As indicated in Article 16, I sought but failed to obtain the full and informed consent of the potentially affected clients.

5. As I am no longer able to discharge my professional obligations to Mr Al Hassan, it is necessary for me to seek the Chamber's leave to withdraw.

6. After my withdrawal from representation, I will continue to adhere to all relevant provisions of the ICC Code of Professional Conduct for Counsel concerning confidentiality and record-keeping as provided in Articles 8, 15 and 17, as well as the relevant provisions of the Dutch Code of Conduct.
