- 1. The Prosecution welcomes the observations filed in response to its appeal,<sup>1</sup> including those on behalf of Afghanistan<sup>2</sup> and the three observations filed on behalf of victims participating in these proceedings by the Office of Public Counsel for Victims,<sup>3</sup> by Ms Nasiri,<sup>4</sup> and by Mr Moloney et al.<sup>5</sup>
- 2. Pursuant to regulation 24(5) of the Regulations of the Court, the Prosecution seeks leave to file a brief reply addressing aspects of the observations made by Mr Moloney et al. On the face of these observations, certain aspects appear to be inadmissible because they address matters beyond the scope of the present appeal proceedings,<sup>6</sup> which relate only to paragraph 59 of the Pre-Trial Chamber's decision.<sup>7</sup> If these observations are inadmissible, they should be summarily dismissed for the purposes of this appeal. In any event, the Prosecution could not reasonably have anticipated these arguments in its Appeal Brief.
- 3. If it would assist the Appeals Chamber, the Prosecution proposes to file a reply of no more than three pages (not including cover pages) by 16 January 2022 where it would demonstrate that these aspects of the observations of Mr Maloney et al.<sup>8</sup> are inadmissible and misunderstand the Court's legal framework.
- 4. The Prosecution notes that the focused nature of this request, and its proposed reply, does not necessarily imply its agreement with the relevance or content of all
