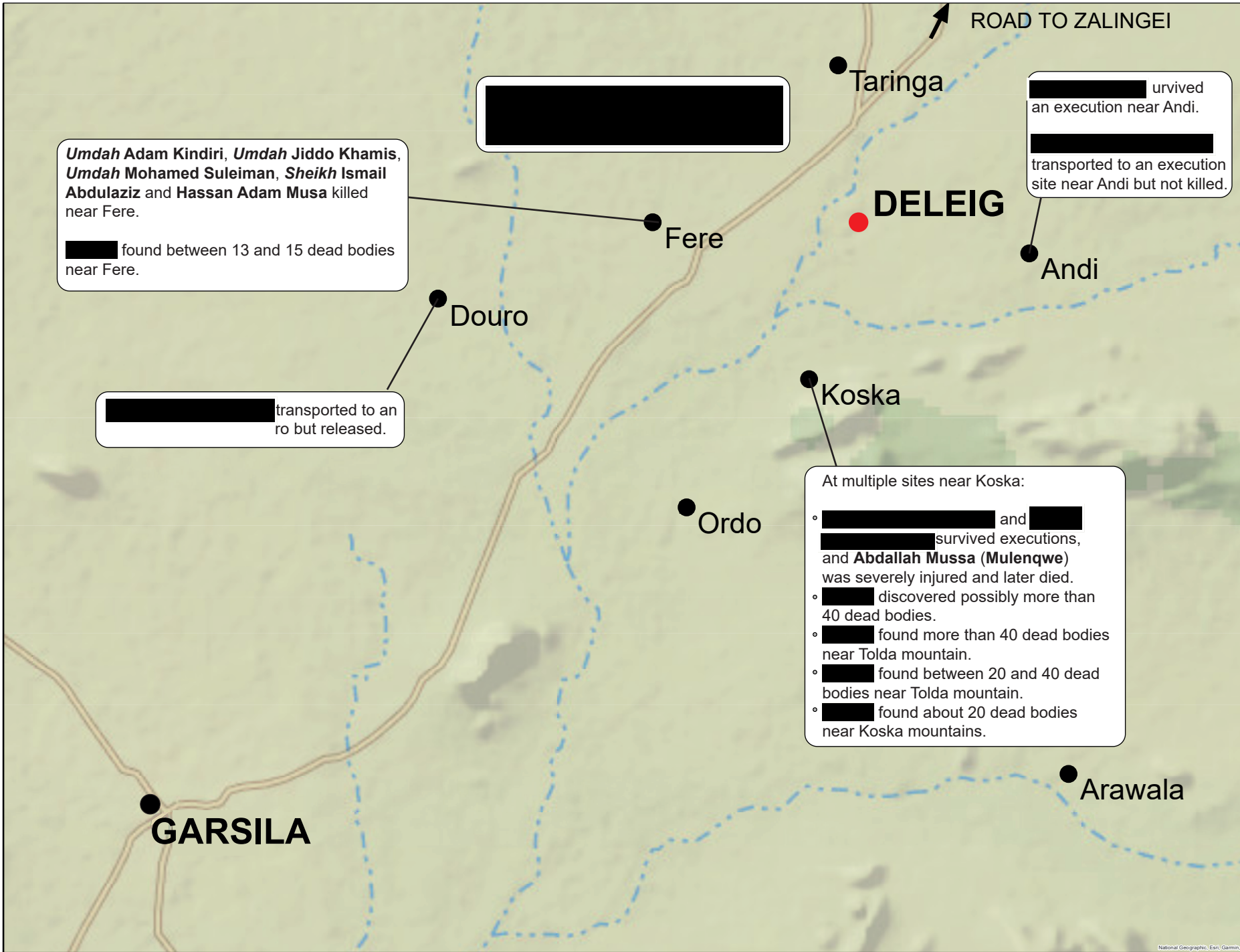

# Annex 22 - Locations relevant to known executions sites outside Deleig



*Umdah Adam Kindiri, Umdah Jiddo Khamis, Umdah Mohamed Suleiman, Sheikh Ismail Abdulaziz and Hassan Adam Musa* killed near Fere.  
 [Redacted] found between 13 and 15 dead bodies near Fere.

[Redacted] transported to an [Redacted] but released.

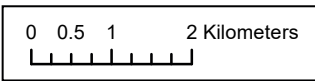
