Dear Counsel and Registry,

The Defence requests to recognise 14 items as formally submitted (Email from the Defence, 22 March 2022, at 17:47). The Prosecution requests that 3 items are recognised as formally submitted (Email from the Prosecution, 22 March 2022, 18:13).

The Prosecution submitted a response to the Email of the Defence (Email from the Prosecution, 25 March 2022, at 9:59), objecting to two items submitted by the Defence.

The Defence submitted a response to the Email of the Prosecution (Email from the Defence, 25 March 2022, 10:39), stating that it has no objections to the items submitted by the Prosecution.

First the Chamber notes that there are no objections to the items submitted by the Prosecution.

Further, all items put forward for submission by the Prosecution have been discussed in one form or another during the witness's testimony. Accordingly, the Chamber recognises all items put forward by the Prosecution as formally submitted.

Items 1-4, 6-9 and 11-14 of the Defence list

With regard to the items put forward by the Defence, the Chamber notes that items 1-4, 6-9 and 11-14 are all prior recorded testimonies. As previously explained, such items must be introduced in accordance with Rule 68 of the Rules of Procedure and Evidence. The Chamber does not recognise these items as formally submitted.

Item 5 of the Defence list (KEN-OTP-0141-0026)

The Prosecution objects to the recognition of KEN-OTP-0141-0026. It argues that the item does not concern the witness and that P-0516 'could not have confirmed any of the actual content'.

The Chamber notes that during the question of P-0516, the Defence did not actually show the witness the item in question ('You don't have to look at it.' ICC-01/09-01/20-T-064-Conf-Eng, p. 15, line 24; repeated on p. 16, line 1). The examining counsel wanted to put to the witness how he initially made contact with the ICC and the witness answered that question.

Accordingly, in the current instance, the Defence is trying to submit the item in accordance with the procedure for 'items of evidence used during a hearing' (see, Directions on the Conduct of the Proceedings, ICC-01/09-01/20-189, para. 17 (i)) without having shown the item to the witness. As explained in previous decisions on submitted evidence, this is not the applicable avenue.

For the reasons above, the Chamber does not recognise item 5 of the Defence's list as formally submitted.

Item 10 of the Defence List (KEN-OTP-0157-2598)

The Prosecution objects to the submission of KEN-OTP-0157-2598, arguing that it is not related to P-0516 and that the witness did not confirm any of its content.

The Chamber notes that the item in question is a conversation between two Prosecution witnesses who, amongst others, talk about P-0516. The Defence read part of the document to the witness and questioned him about the content and the inferences the Defence draws from it (ICC-01/09-01/20-Conf-Eng p. p. 4, line 7 - p.5, line 19). The Chamber finds that – after having discussed the item with the witness – the fact that the witness did not provide a substantive comment on the matter does not bar the Defence from requesting that the item be recognised as formally submitted. The Prosecution raises aspects which concern the assessment of the evidence which, as previously explained, will be done at a later point in time.

Accordingly, the Chamber recognises item 10 of the Defence list as formally submitted.

In summary, for P-0516, the Chamber recognises all items requested by the Prosecution and item 10 requested by the Defence as formally submitted.

The Registry is directed to proceed in accordance with paragraph 17(iv) of the Directions on the Conduct of the Proceedings, 7 October 2021, ICC-01/09-01/20-189.
