The Chamber notes the submission of 9 items by the Prosecution following the testimonies of P-1048 and P-1049 (*see* email of 1 February 2023, at 09:45).

The Defence does not object to the submission of items 1-5 on the Prosecution's list of material for submission, but does object to the submission of items 6-9 (*see* e-mail of 1 February 2023, at 20:33).

The Chamber notes that the Prosecution is no longer intending to submit items 6-9 on its list for submission (*see* e-mail of 2 February 2023, at 16:08).

Noting that the submission of items 1-5 is unopposed, the Chamber hereby recognises these items as formally submitted.
