Dear Trial Chamber I, Dear colleagues,

The disorganised approach of the Defence to the presentation of its case and the late disclosure of statements and order of witnesses is becoming increasingly prejudicial to the Prosecution's right for adequate time to prepare. The Prosecution notes that the *first* meeting on witness appearances with VWS was not held until yesterday. The Prosecution also notes that witnesses D-0006, D-0008 and D-0011 were listed as testifying *viva voce* in this block in The Hague although the Defence knew or should have known that they did not have passports.

First, the Prosecution objects to the inclusion of expert witness Fiona Marsh at such late notice; the Prosecution will be requesting additional materials which should be part of every expert witness' package.

Second, regarding D-0016, the Prosecution received his 44 page statement on Thursday evening, 28 October, but a number of items referenced in the statement were not provided. Some of these outstanding items were provided late yesterday evening, but a number remain outstanding.

At this stage the Prosecution anticipates 1-2 sessions each for its cross-examination of witnesses D-0016, D-0006, D-0008 and D-0011.

Honourable Judges, Dear Colleagues,

Yesterday, the Defence had its first meeting on witness appearance with VWU.

The outcome of this meeting is that it is already too late to arrange for Witness D-16's in-person appearance starting on 18/10, but his appearance can start on 23/10.

This leads me to reorganize the order of appearance of the Defence witnesses over the first block as follows:

- on 18-19-20/10, AVL appearance of Defence Witnesses D6, D8 and D11 from **Control**: we wish these three witnesses could have appeared from The Hague, but they have no passport, the position of the Court is that it cannot issue a travel document for them and they thus cannot travel;
- on 23-27/10, in-person appearance of Defence witness D16.

We are still awaiting confirmation of the time OTP expects its cross-examination of Witness D-16 to take. My Examination-in-Chief should take 3 full days. In case we can anticipate additional room for another witness over that block, we may add to the list Expert Witness Fiona Marsh. This will depend on OTP's feedback on its cross-examination of Witness D-16.
